This cookie policy describes our and our subsidiary companies' ("we," "us" or, "our" in this cookie policy) use of cookies and describes how you can manage your cookie preferences.

1. What are cookies?

A cookie is a small piece of data that a website asks your browser to store on your computer or mobile device. 3. How long do cookies last?
