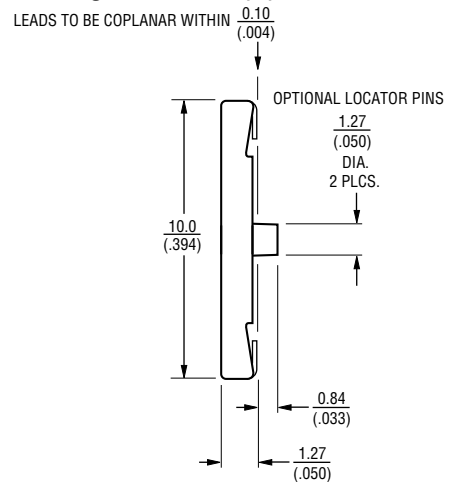

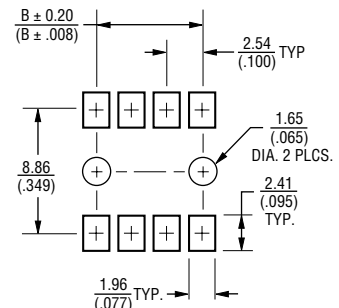
Standard Version (-0)

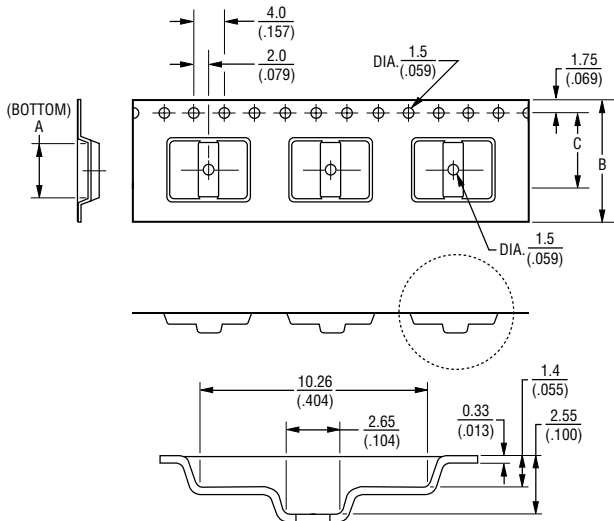

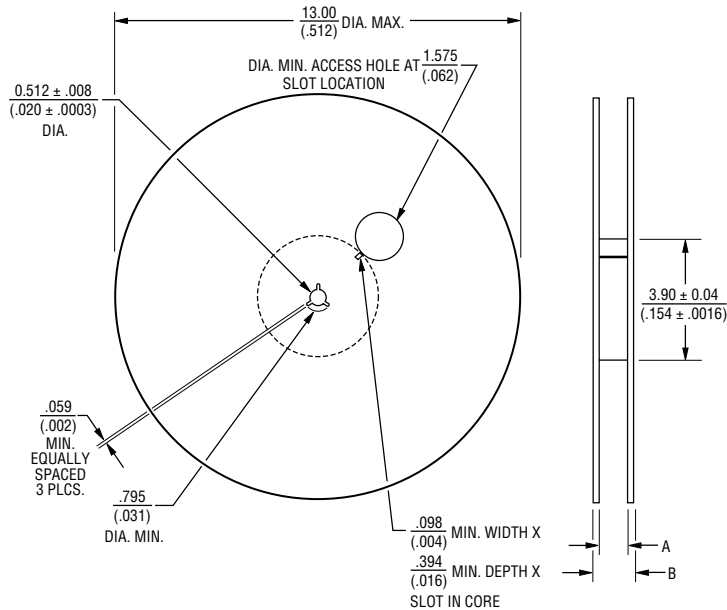
