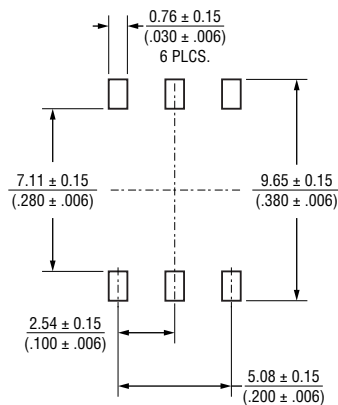
### Product Dimensions

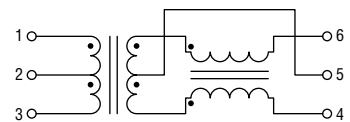


### Recommended Layout

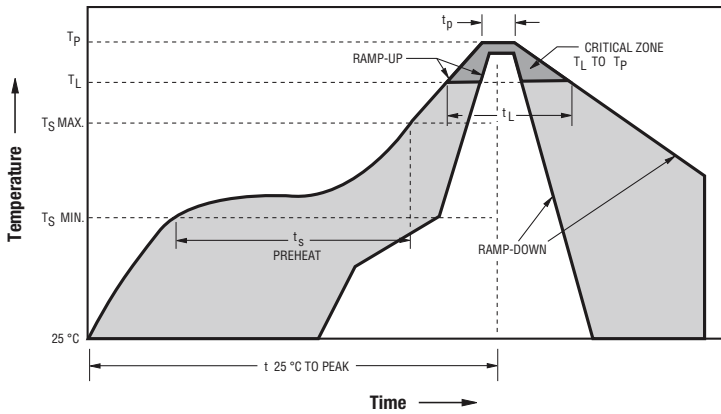

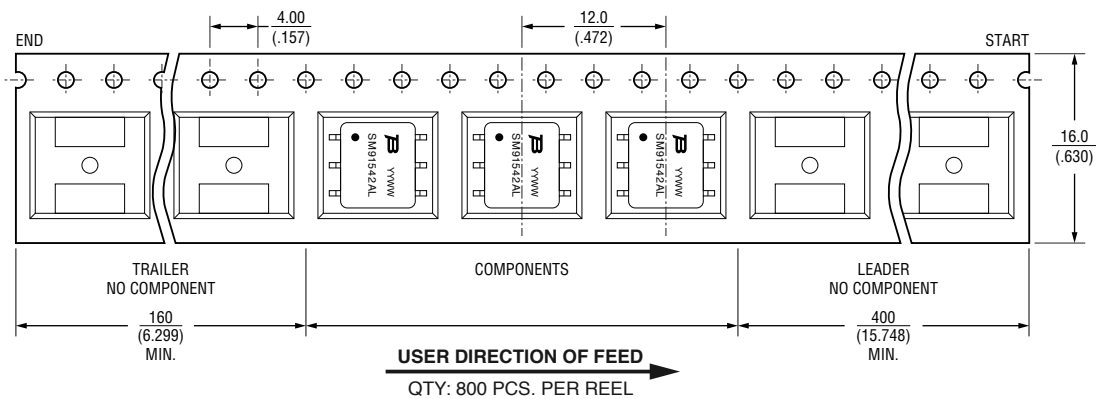
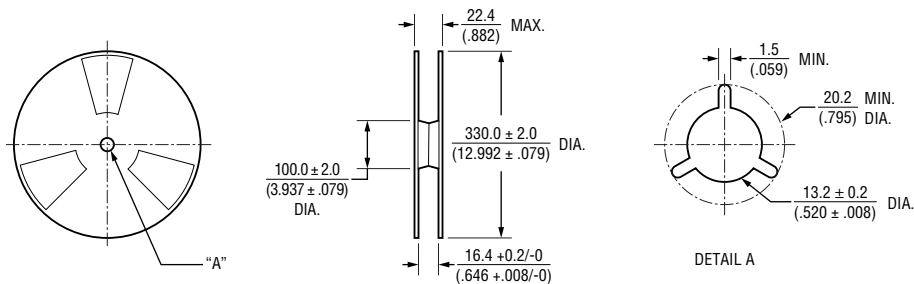
