Product Overview

The ACXX18SQ Series Air Coil Inductors feature high Q values up to 130 with inductances ranging from 8.1 to 33 nH. Engineered with tight tolerance, DCR ratings from 6.0 to 12.0 mΩ max., and rated current of 4.4 A, their flat top and bottom for mechanical stability makes this series suitable for pick-and-place processes for surface mount designs.

These Air Coil Inductors are available with an operating temperature range of -25 °C to +125 °C and are well-suited for use in high frequency television and radio receivers, radio transmitters, RF amplifier and tuning applications.

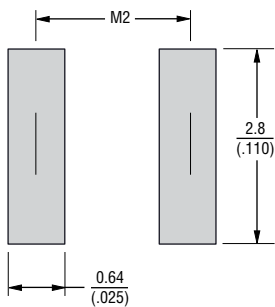

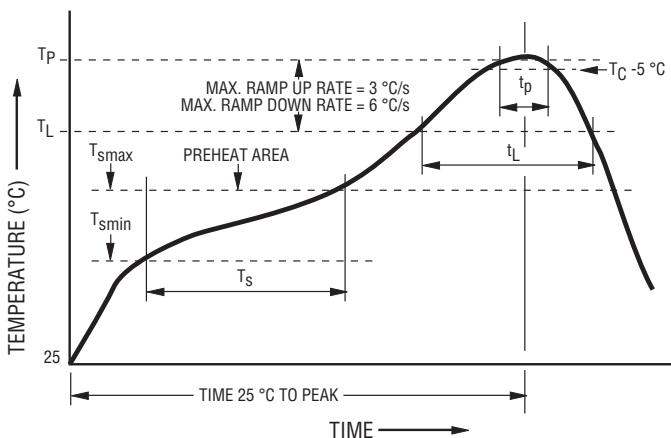

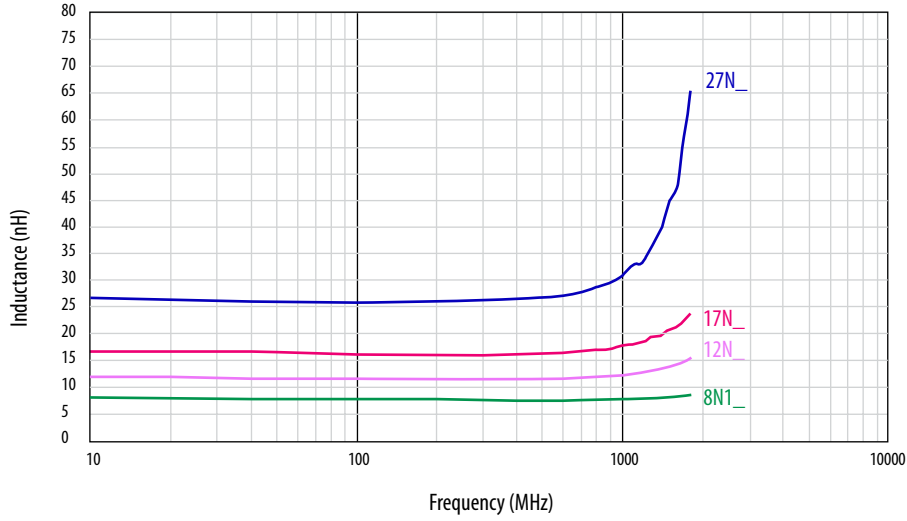

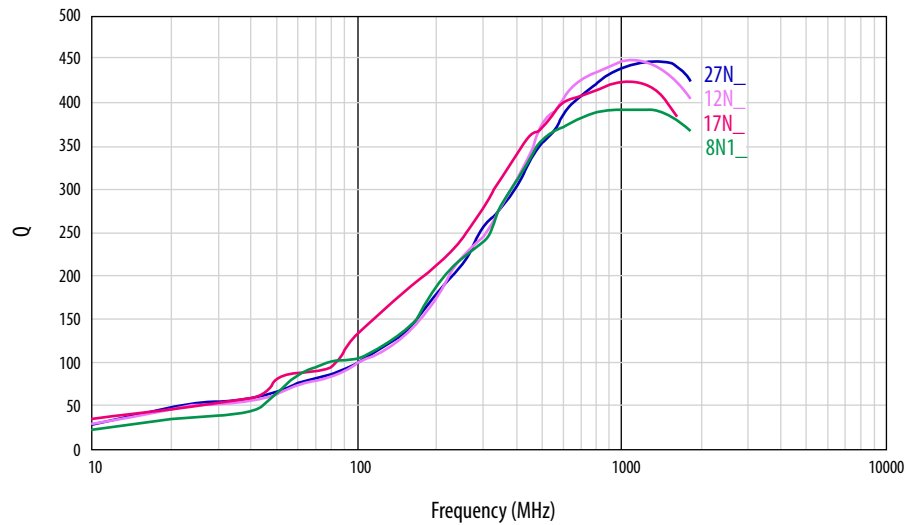

Typical Q vs. Frequency

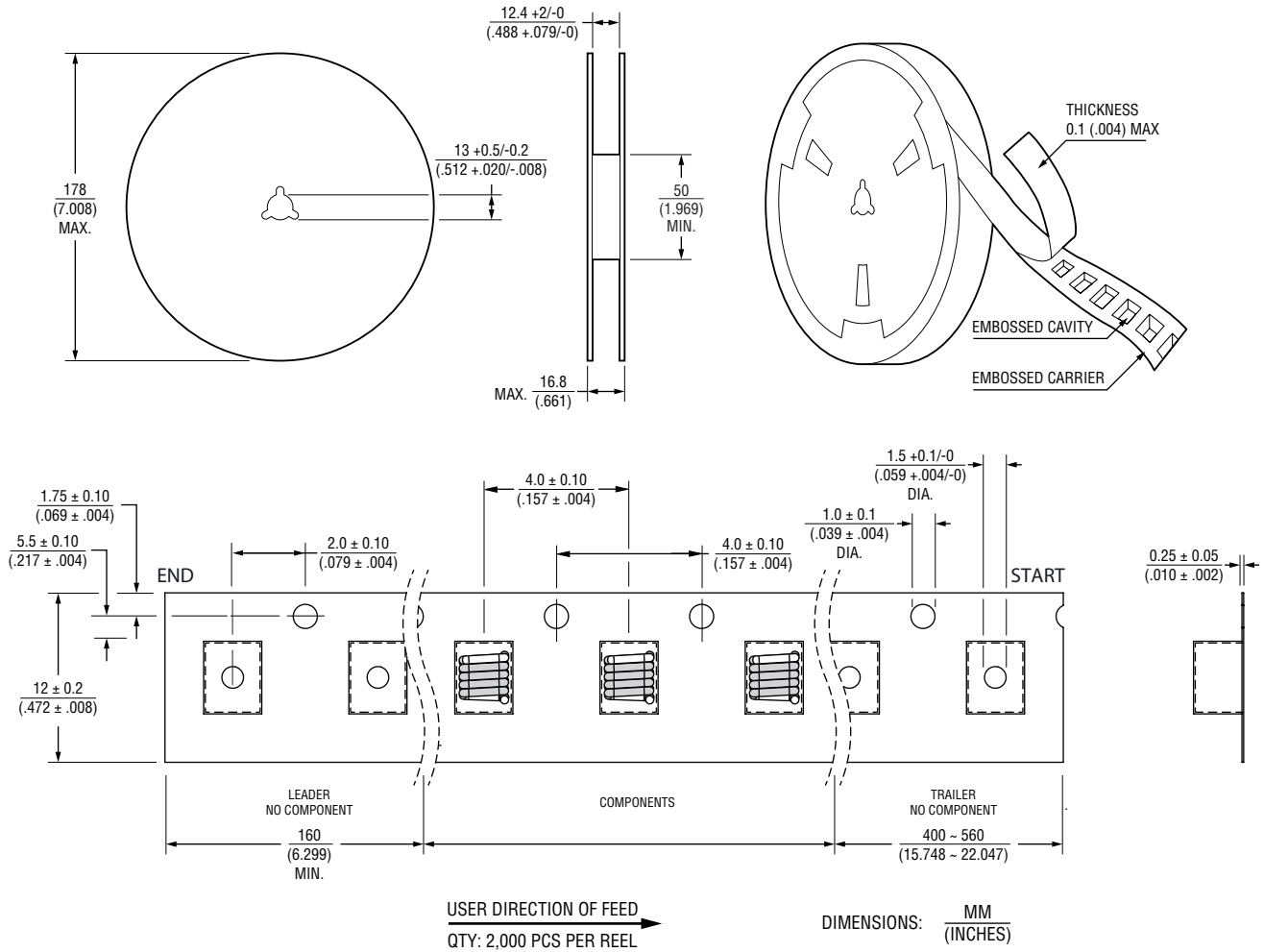
