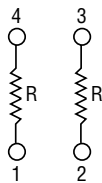

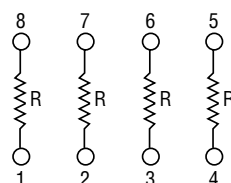

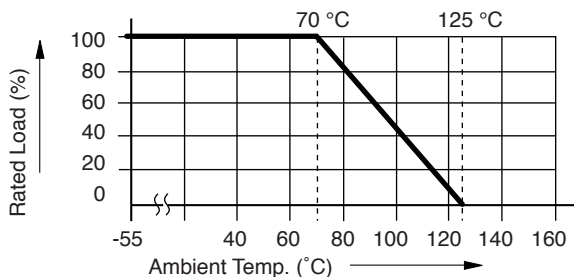

Derating Curve

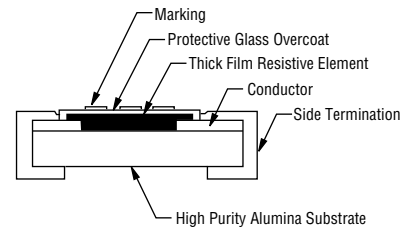

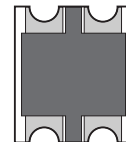

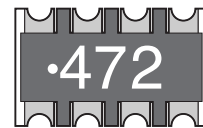


Typical Part Marking

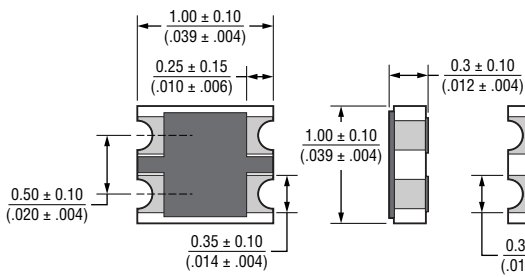

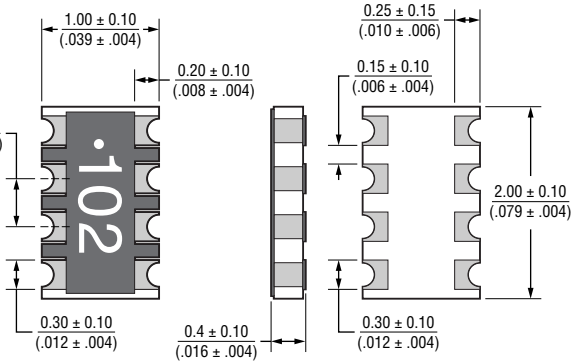

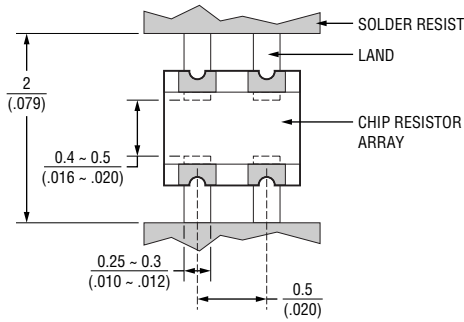
CAT10A-xxxJ4LF



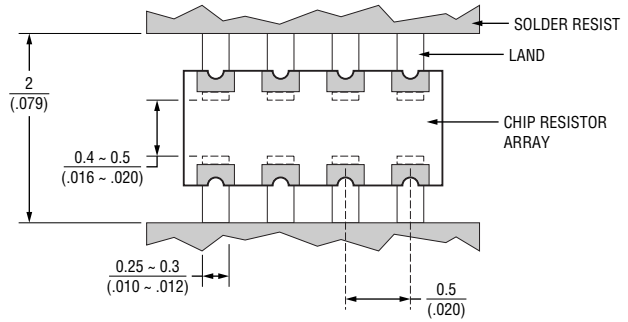

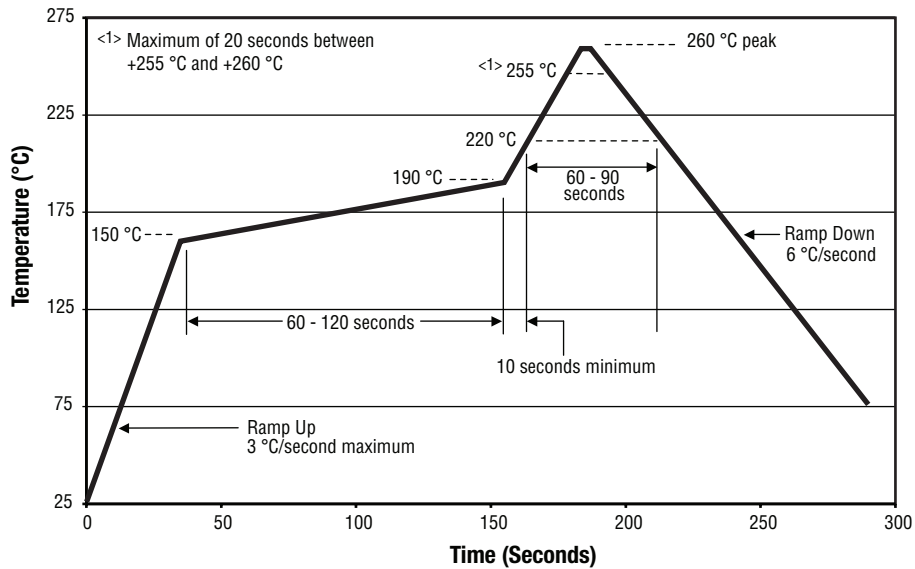

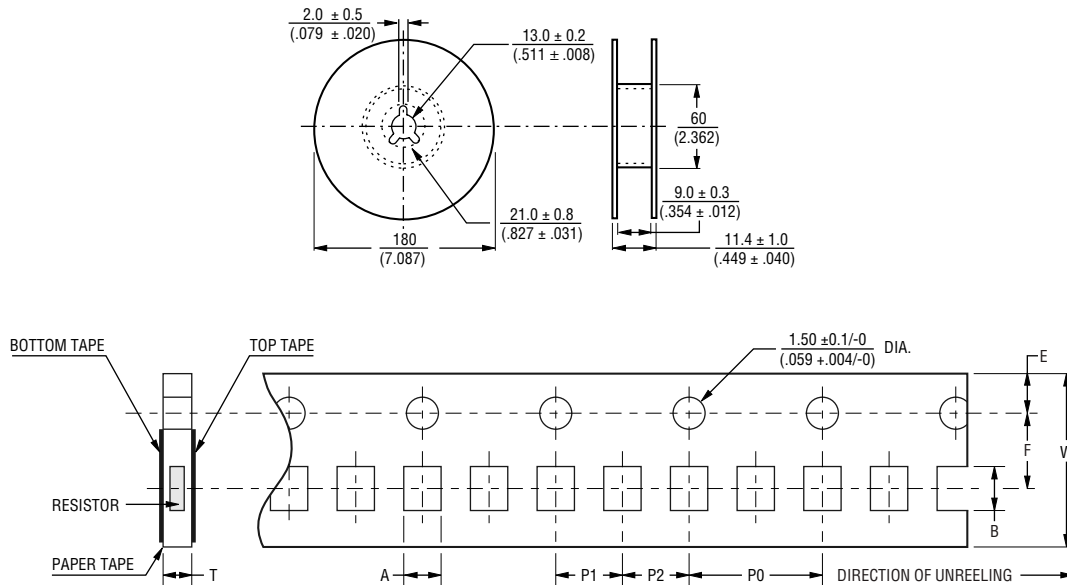
