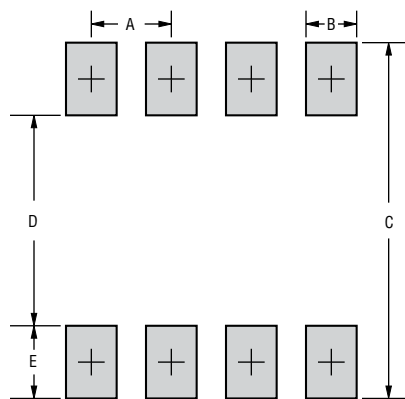

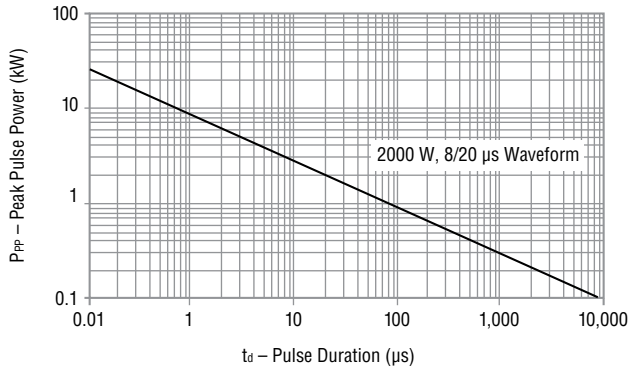

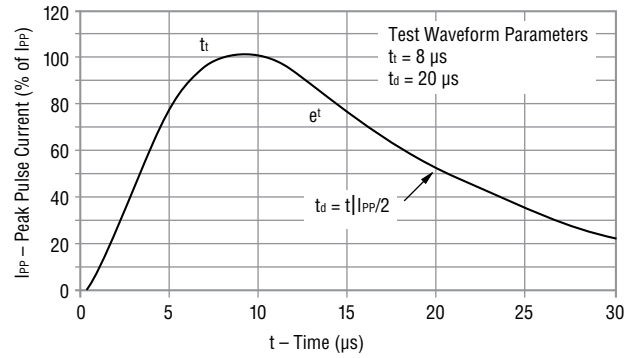

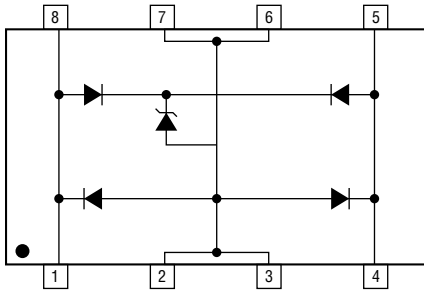
Peak Pulse Power vs Pulse Time



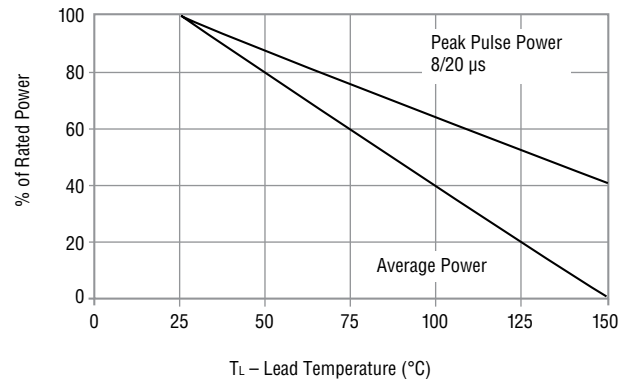
Pulse Waveform

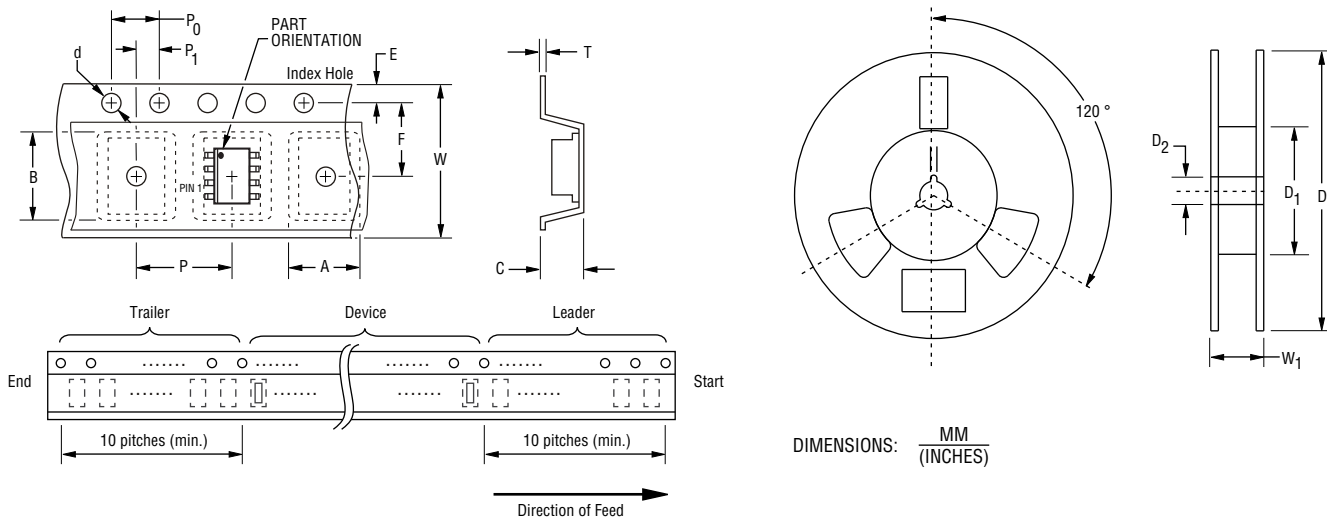
