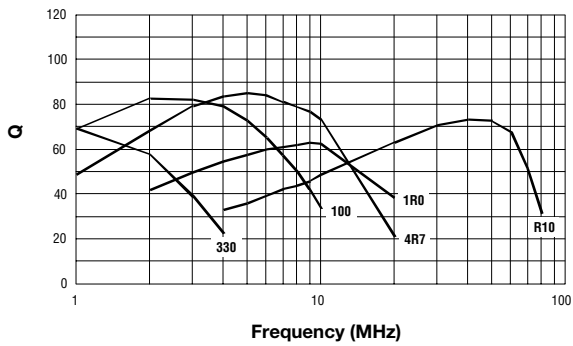

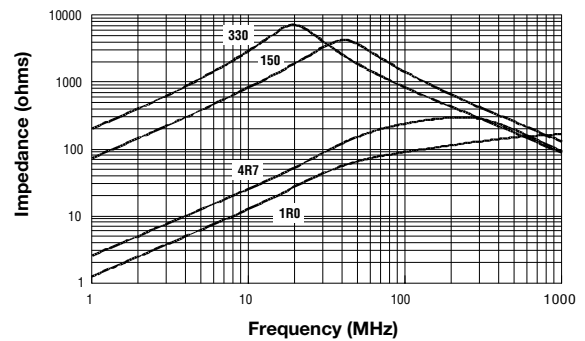
### DC Bias Characteristics
