TOP VIEW

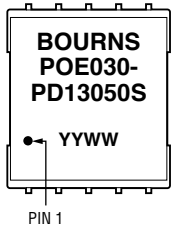


FRONT VIEW

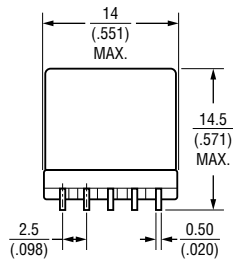
