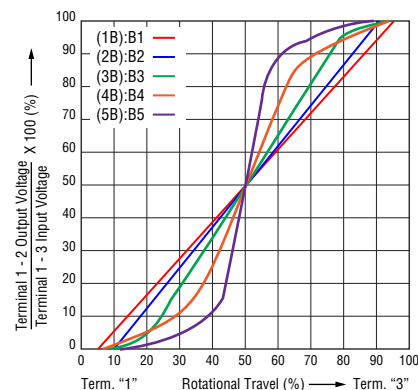

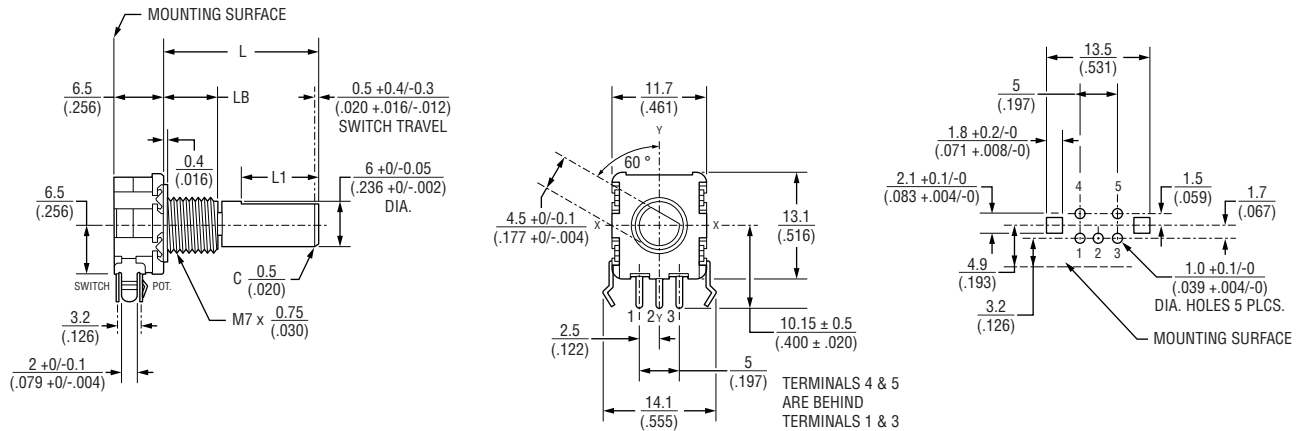

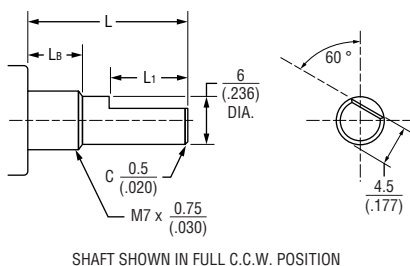

Shaft and Bushing Dimensions

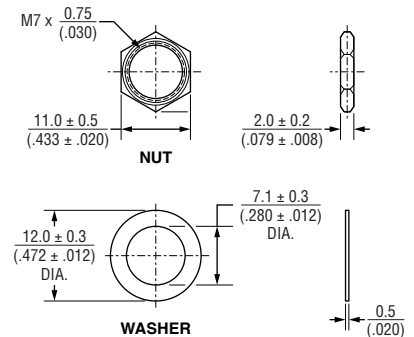

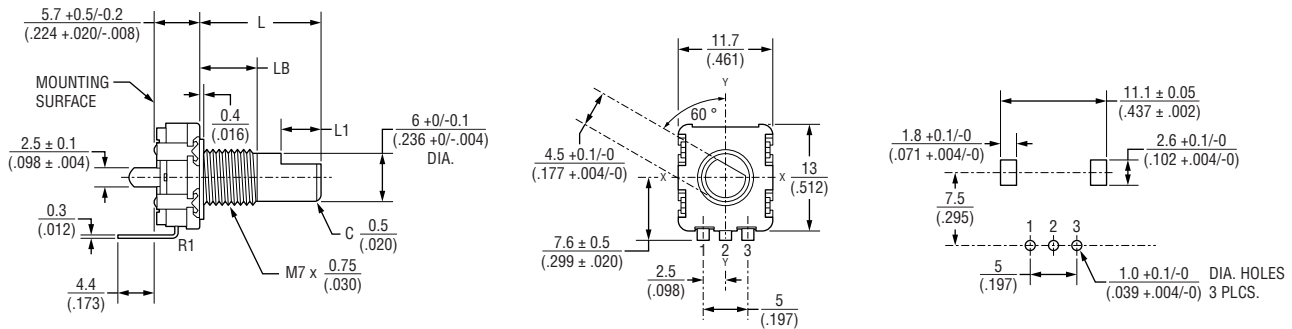

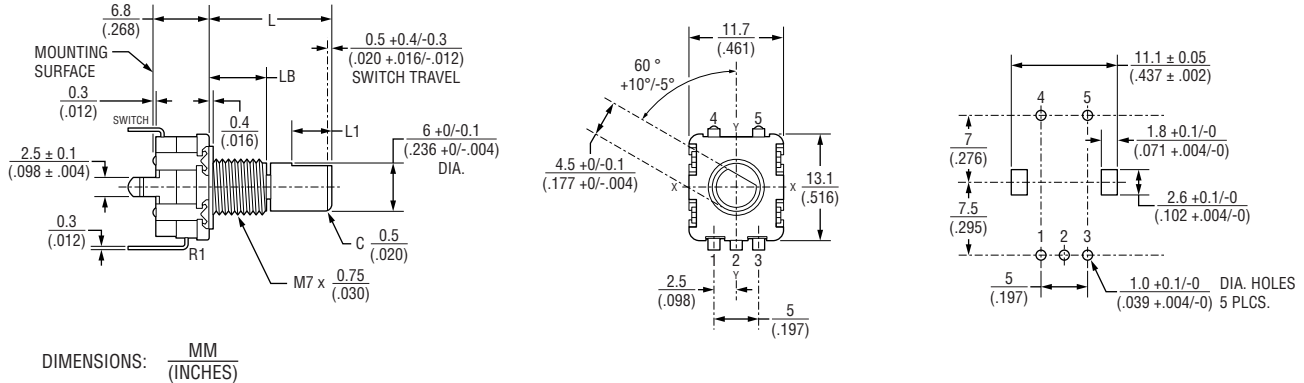
