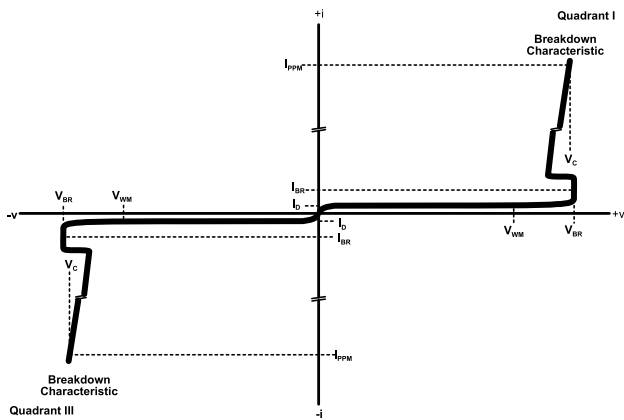

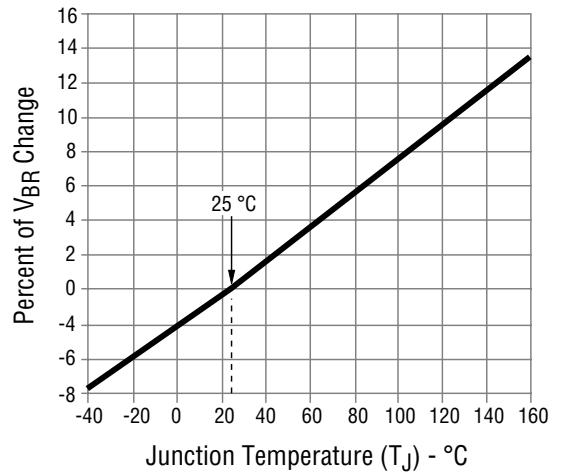

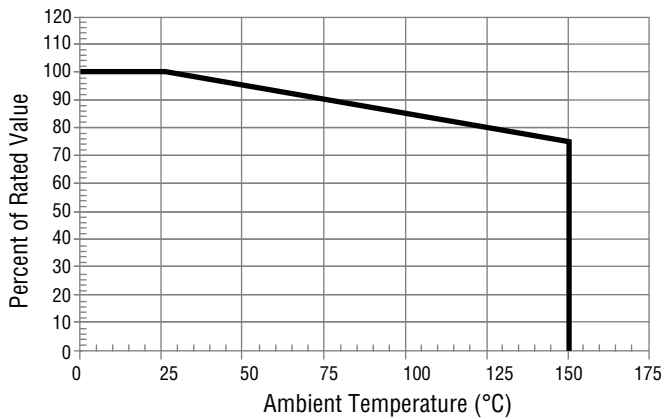
V-I Characteristic



Typical  $V_{BR}$  vs. Junction Temperature

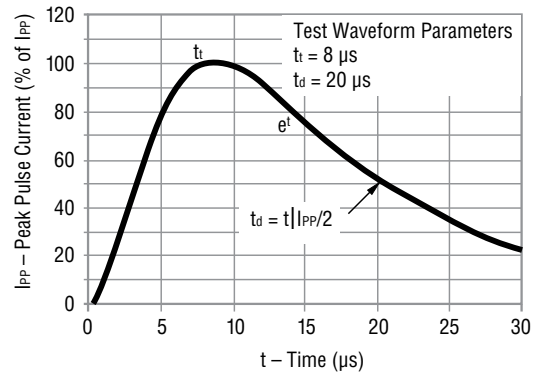


Typical Surge Current Derating

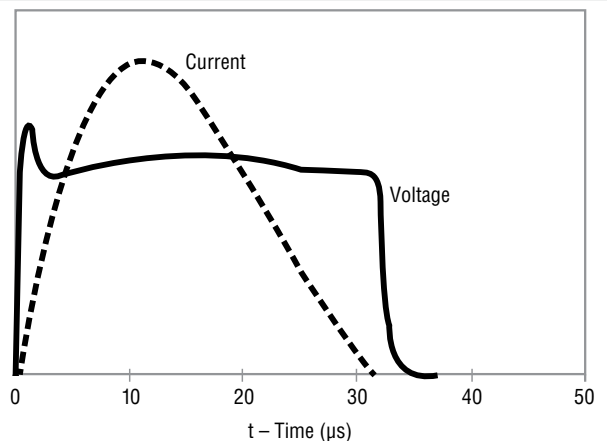

Typical Waveform Under Surge



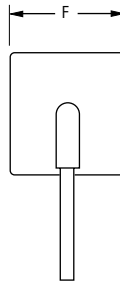
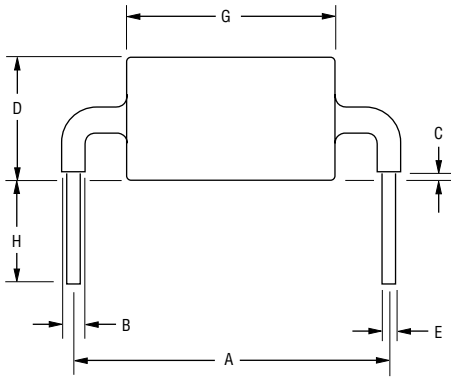

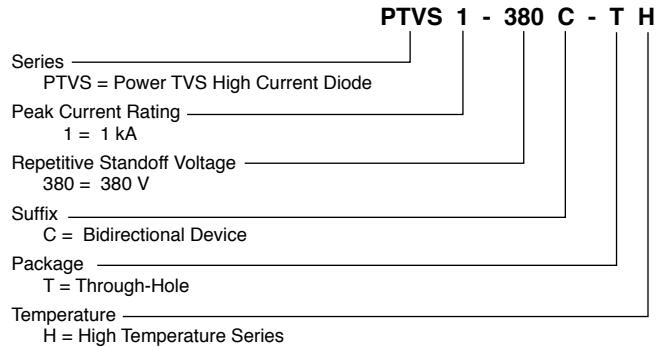
