Temperature Rise vs. IDC

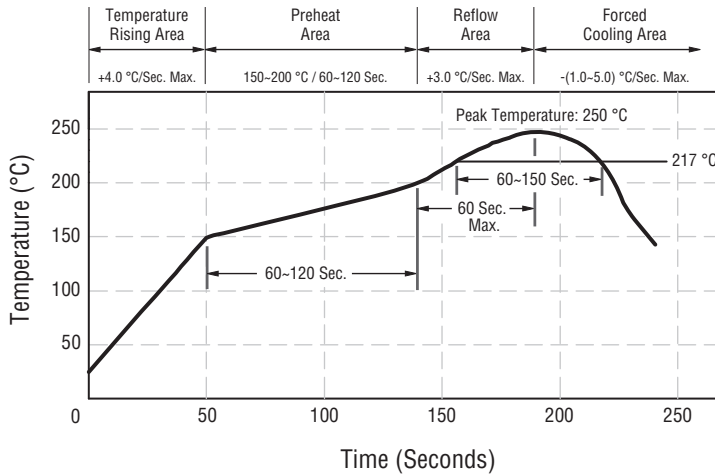

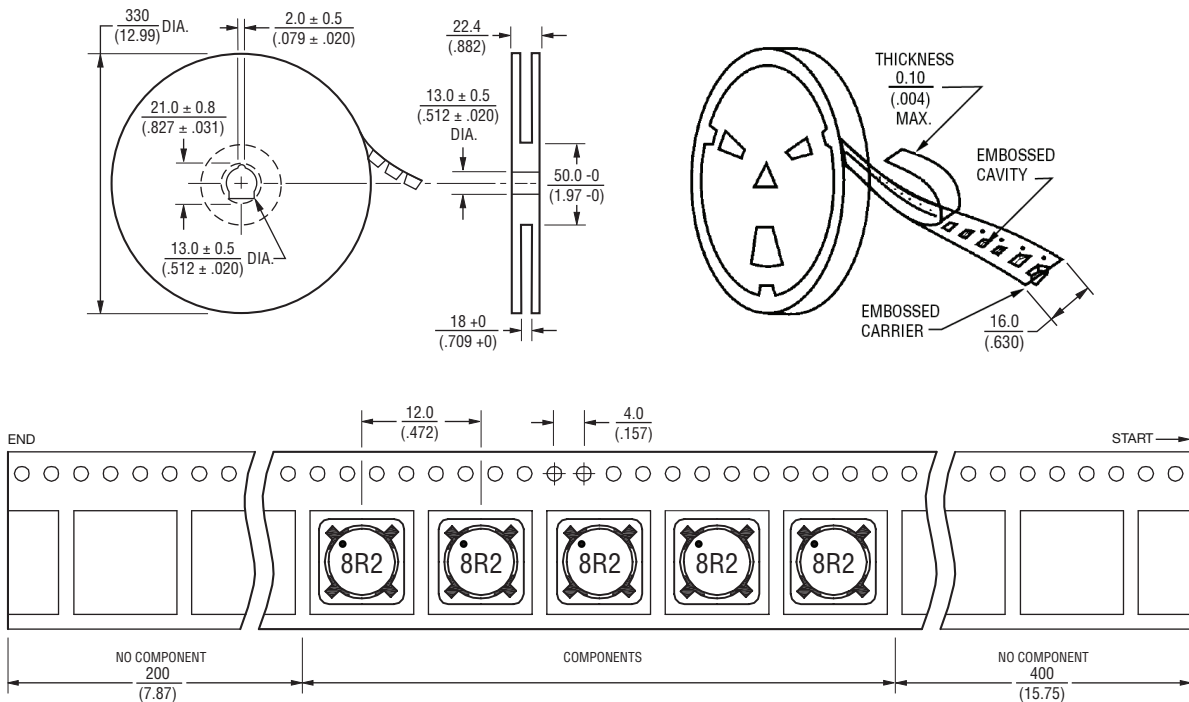
