L vs. I Charts

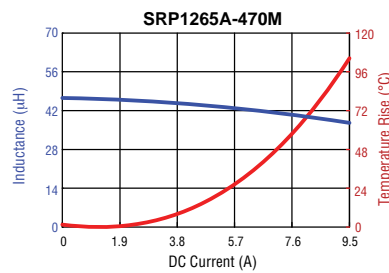
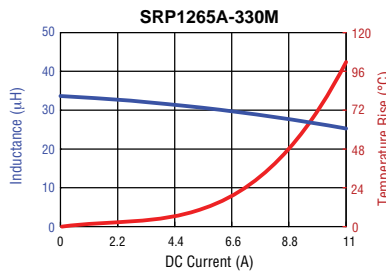
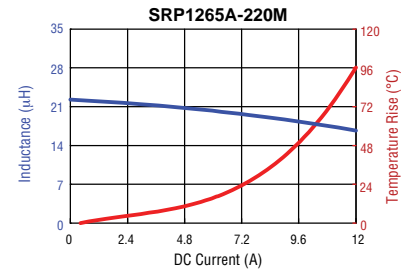
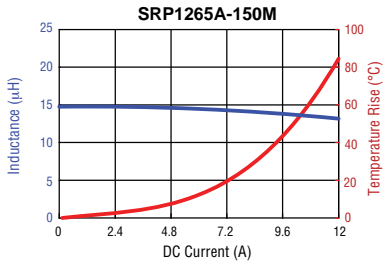
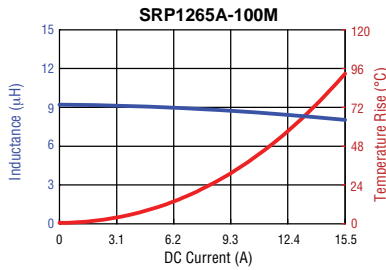
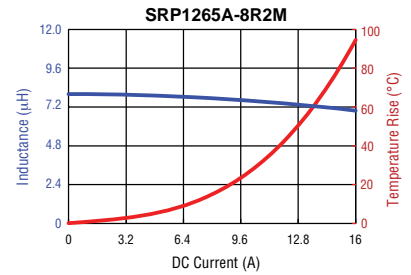
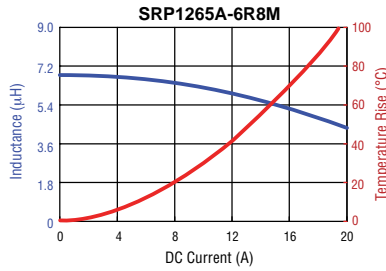
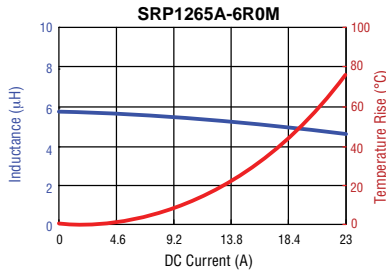

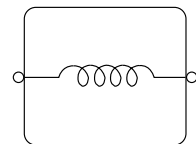
L vs. I Charts (Continued)
