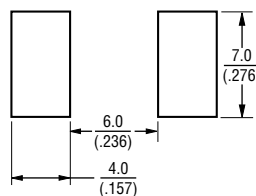

Recommended Layout



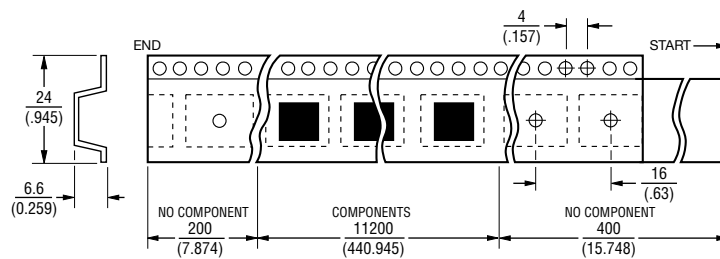
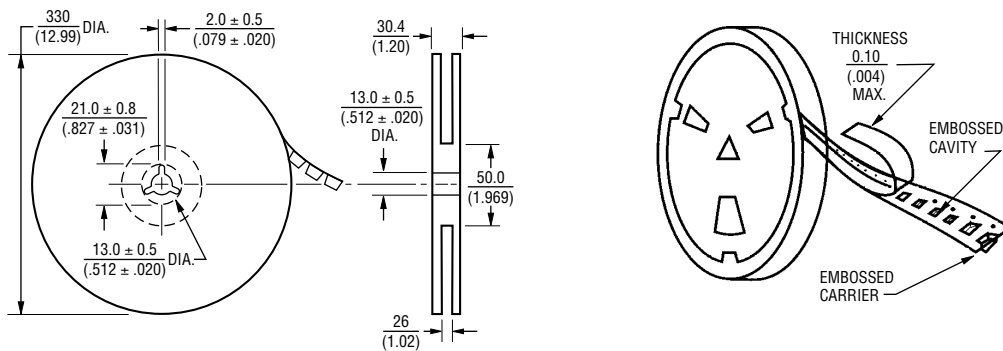
