Riverside, California — April 30, 2025 — To accommodate increasing production demand and in the spirit of continuous improvement, effective July 1, 2025, Bourns will begin using an additional PCB process supplier for select Bourns® Multifuse® PPTC Resettable Fuses. This change will improve the flexibility of process management and sourcing lead time. The additional supplier has been qualified and included in Bourns' Authorized Vendor List. The fit, form, function, quality and reliability of the affected part numbers will remain the same. The MF-MSHT, MF-USHT, MF-PSHT and MF-FSHT Series with the additional PCB supplier will continue to be RoHS compliant*.

Samples built using the additional PCB supplier are available upon request. Bourns recommends that customers test the affected part number made with the additional PCB supplier in their specific applications for verification of satisfactory performance.

Implementation dates are as follows:

Date that deliveries of products manufactured from the additional supplier will begin: *July 1, 2025* First date code from both PCB process suppliers: *5M*

Orders for the affected part numbers received after July 1, 2025 may be filled interchangeably from either the existing supplier or the additional supplier.
